Clearwater's **Division Chief of Emergency Management**, **Jevon Graham**, is a Rockstar! He works around the clock before and during

a hurricane event. With the arrival of Hurricane Ian, Jevon's been the conduit between national, state, and local experts and all information related to Clearwater's preparation, response, and recovery actions. He communicates with Clearwater leadership nearly hourly or as the situation requires. He is a calming presence, and we are lucky to have him as Chief of Emergency Management.

Many thanks too, to **Clearwater employees** who help ensure our communication is accurate and effective, those who field desperate phone calls, those who respond in person to emergency calls, those who work the phones to reschedule and coordinate the business of the city, and those who help clear roadways and sidewalks.

I offer sincere appreciation, too, to **Duke Energy workers** who literally work around the clock to restore power and help clear our roads. It takes effective leadership and coordination of multiple moving parts to weather the storm. Thank you to everyone who has given so much to keep us safe.

Assessing the effects of Hurricane Ian, it's clear things could have been much worse for us here at home. My heart goes out to everyone affected by the catastrophic events of Hurricane Ian. As I learn of them, I'll be sure to communicate opportunities for us to help our neighbors to the south.

Clearwater Council Reduces Millage Rate by .07%



While my heading indicates the Council reduced the millage rate by .07%, as I write this, it is not yet official. Our September 29th Council meeting to have a second reading of and approval of the budget was cancelled due to Hurricane Ian. This millage reduction will most likely be approved on a second reading at our next Council meeting. However, because property values

have increased, residents will still pay more on their tax bills than last year, but they will pay \$7 less per \$100,000 than they would have under the originally unchanged rate.

Council directed staff to cut \$1 million from the budget to allow for this rollback. City services/staff affected include cutting the recommended additional librarian, assistant librarian and extend hours at the North Greenwood Library, custodial staff to open public restrooms at six city parks, a neighborhoods outreach liaison, and money for street and sidewalk repair.

This year, "post Covid," we'll have a large group celebration after the painting is complete. Airpark Presentations Lead to Community Engagement



The Sept. 15 Council meeting was a lively one. On the agenda was a vote

to approve staff's recommendation to being negotiations with FlyUSA and Paradise Ventures on potentially becoming the new fixed-base operator of the Clearwater Airpark. After 14 public comments from pilots, residents, flight school students, attorneys, developers, and the Airpark Advisory Board Chair, along with a number of emails sent directly to Council, we voted unanimously to allow staff to being shaping an operation agreement with FLYUSA and Paradise Ventures.

Clearwater Airpark is 80 years old and in need of long deferred maintenance. Flight take-offs and landings have increased exponentially within the last 10 years, including a marked uptick in helicopter traffic that has impacted the quality of life for nearby residents. Additionally, there is interest in creating a more "family friendly" or community atmosphere at the airpark. There are a number of competing interests, and it will be important to seek a balance in use that will be beneficial to the city, the users of the airpark, and our residents. The General Election Is November 8... Take Action Now to be an Informed Voter



We have a general election coming up on Nov. 8 and it's imperative that voters get informed and vote! You can register to vote and/or check your voter registration at our Pinellas County Supervisor of Elections
The last day to register to vote for this November's election is Oct. 11. Voters will be voting for state and local officials, US Senator and Representative, judges, three

Florida Constitution amendments, and a Clearwater Charter amendment for our Bluff development referendum.

Elected officials decide what government does and how it serves the people. They decide the standards, protections, and services, and who benefits and who pays. Services could include education, clean water and air, health care, decent housing, unemployment benefits, public safety and the courts.

City Charter Amendment Bluff Referendum on November Ballot

The Pinellas County Supervisor of Elections will mail out vote by mail



ballots on Oct. 6 for our Nov. 8 election. The last question on the ballot for Clearwater voters is the following question:

"Shall the Clearwater City Charter be amended to allow the City, instead of selling the vacant City Hall and a portion of the former Harborview sites to the highest bidder at a public auction, to sell the properties to Gotham Property Acquisitions and The DeNunzio Group; who will create approximately 600 apartments and 158-key hotel, retail, entertainment, restaurants and cultural uses available to all Clearwater residents, as further described and limited by City Ordinance 9597-22?"

According to **Greenprint 2.0**, Clearwater's Sustainability Action Plan, electricity is the biggest contributor to our community-wide greenhouse gas emissions, with most of that electricity being used for lighting, cooling, and heating of buildings. Transitioning to solar can reduce the use of fossil fuels, reduce carbon emissions that contribute to climate change, save money, and create jobs.

Non-profit **Solar United Neighbors** is hosting the Pinellas 2022 Solar Coop, and Clearwater residents are invited to join. The co-op is free to join. Members will learn about solar energy and leverage their membership numbers to obtain competitive pricing and high-quality solar panel systems.
